The photographs, digital negatives or prints produced by The Photographer are protected by The Copyright and Design Act 1988 and may not be reproduced in any manner without The Photographer's explicit written permission subject to the provisions of the paragraph relating to the purchase of digital negatives.

The Client hereby assigns and grants Mark Bradford Studios the irrevocable and unrestricted right to use and publish photographs resulting from this assignment for editorial, trade, advertising or any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same.

### **Limit of Liability:**

In the unlikely event of severe medical, natural, or other emergencies, it may be necessary to retain an alternative photographer. The Photographer will make every effort to secure a replacement photographer able and/or willing to provide the same package as chosen in this contract at the same

tariff. If such a situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event package.

Mark Bradford Studios takes the utmost care with respect to exposure, transportation and processing of photographs; including using professional grade equipment and professional grade backup equipment. However, in the unlikely event of The Client's photographs being lost, stolen or destroyed for reasons within or beyond The Photographer control, the latter's liability is limited to the return of all payments received for the event package.

**Non-Guarantee:**

Although every possible care will be taken to produce photographs of all important and special events during the wedding, The Photographer cannot place an unconditional guarantee on the above.

**Cancellation:**

In the event that The Client cancels the contracted services for wedding photography before the wedding ceremony takes place, the Booking Fee will be forfeit. The Photographer agrees to refund all additional paid money (less expenditures for which receipts will be provided), to The Client.

**Purchase of Digital Negatives:**

If The Client purchases a copy of the high-resolution digital negatives, these images will be supplied on CD/DVD along with a perpetual unlimited licence for The Client to distribute, print or publish the images in any way they see fit other than for commercial gain.

**Payments:**

The Photographer will reserve the agreed date, and will not make other reservations for that date. For this reason, the Booking Fee of £350 is non-refundable, even if the date is changed or the wedding cancelled for any reason; including acts of God, fire, strike and/or extreme weather. The Booking Fee is applied towards the contracted wedding photography package. The entire amount owed for the wedding photography package is due one month prior to the date of the Wedding.

In the event that the wedding is rescheduled for a different date from the one agreed, The Photographer will, subject to availability, rebook the same package at the same price and the booking fee will be applied to the new arrangement.
